

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OR RISK, AND INDEMNITY AGREEMENT (“AGREEMENT”)

In consideration of participation in the SPORT OF PAINTBALL I represent, that I understand the nature of the activity and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participating in the Activity.

I fully understand that this Activity involve risks of serious bodily injury, Including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participation in the event, the conditions in which the event takes place, or the negligence of the “releases” named below, and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility of losses, costs, and damages I incur as a result of my participation in the Activity.

I hereby release, discharge, and covenant not to sue Paintball Knights, its Respective administrators, directors, agents, officers, volunteers, and employees, other participants and sponsors, advertisers and if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the “RELEASES” herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence or the “RELEASES” or otherwise, including negligent rescue operations; I further agree that if, despite this release, waiver of liability, and assumption of risk I, or anyone on my behalf makes a claim against any of the Releases, I will indemnify, save and hold harmless each of the releases from any loss, liability, damage, or cost which any may incur as the result of such claim.

I have read this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement and assurance of any nature and intend it be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be valid the balance, notwithstanding, shall continue in full force and effect.

2011 Field Rules

1. All players must wear a mask properly at all times while in the playing area. Any violation will result in IMMEDIATE EJECTION from the game and you will not be able to return on the field for the rest of the day/evening.(No exceptions)
2. Barrel sleeves are required in the staging area at all times. Anyone with air attached to there marker without a sleeve on there marker will be asked to leave the property immediately. (No exceptions)
3. All players are required to use Field Paint only. Only paint purchased here during calendar year is allowed.
4. All guns must be chonoghraped below 299fps. No ramping, full auto or burst modes allowed.
5. 20 foot surrender rule at all times during recreational play.
6. All persons are required to have a safety briefing before “sign in” and entering the playing field.
7. Anyone under the age of 18 must have written permission by a parent or guardian before play is allowed.
8. Field judges are the only people allowed on the field wearing yellow shirts.
9. NO alcoholic beverages are allowed on the property.
10. NO breaking, throwing or squirting paint in the staging area.
11. NO shooting at the field lights.
12. Rental guns can not be taken apart in any way.
